ORDER

Whereas, the association named India Every Home Crusade, #431 (20 Old) Ritherdon Road, Vepery, Chennai – 600007 (Tamil Nadu) is registered under Foreign Contribution (Regulation) Act, 2010 vide Registration No.075901001R.

Whereas, it was found that the association did not file its mandatory FC-6 Returns for the Financial Year 2007-2008. A Show Cause Notice was issued on 13.9.2011 for non-filing of mandatory FC-6 returns for the year 2007-2008 and due to this reason; the association was placed under Prior Permission Category on 28.11.2011.

Whereas, in response to this Ministry's Show Cause Notice dated 13.09.2011, the association replied vide their letter dated 18th September, 2012 and submitted the acknowledgment of submission of FC-6 Returns for the Financial Year 2007-2008 through Speed Post Booking No.ET98020831IN.

Whereas, on the basis of the request received from the association on 18th September, 2012, the Central Government has had the matter examined and an inspection was conducted on 02.03.2015 to 03.03.2015 in the registered office of the association in Chennai (Tamil Nadu) and the said examination has not revealed any misutilization or misappropriation of the foreign contribution received by the Association.

And now, therefore, in exercise of the powers conferred by the aforesaid Acts & Rules. the undersigned hereby expunge the name of the Association, viz. **India Every Home Crusade, # 431 (20 Old) Ritherdon Road, Vepery, Chennai – 600007 (Tamil Nadu)** from the List of associations placed under prior permission category with the instruction that the above association shall follow due diligence while accepting and utilization of any foreign contribution in future and the association will also ensure that the mandatory FC-6 Returns are submitted within the stipulated period to the Ministry. The association is also advised to visit web-site of the Ministry i.e. www.mha.nic.in for regular updates.
