Sub: **Declaration of Assets and Liabilities by AIS Officer under Section 44 of the Lokpal and Lokayuktas Act, 2013- extension of last date for filing of returns by AIS officers – Reg.**

Sir,

Please refer to this Ministry's letter of even number dated 4.7.2016 and DoPT letter dated 28.3.2016 wherein time limit for filing of assets and liabilities for the year 2014, 2015 & 2016 (as on 1.8.2014, 31.3.2015 and 31.3.2016) was extended upto 31.7.2016 under Section 44 of Lokpal and Lokayuktas Act, 2013.

2. DoPT vide their letter No. 407/16/2016-AVD-IV(LP) dated 29th July, 2016 (copy enclosed) have conveyed that the last date for furnishing of declaration/information/annual return as on 1.8.2014, 31.3.2015 and 31.3.2016 relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 has been extended upto **31st December, 2016**. In this regard formal amendments to the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 have been notified by the DoPT vide notification dated 29.7.2016 (copy enclosed).

3. Now the timelines for filing these returns are as follows:-

- i) The first return of assets and liabilities as on 1st August, 2014 – on or before the 31st December, 2016.
- ii) The annual return of assets and liabilities as on 31st March, 2015 – on or before the 31st December, 2016.
- iii) The annual return of assets and liabilities as on 31st March, 2016 should be filed on or before 31st December, 2016.

4. In view of the above, it is requested that these instructions may be widely circulated to all concerned and strict compliance for filing of above returns under the provisions of the Lokpal and Lokayuktas Act, 2013 within the prescribed time through online (SPARROW (PRISM)).

Subject: Declaration of Assets and Liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 – filing of Returns by public servants - extension of last date - regarding

The undersigned is directed to refer to this Department's OMs No.407/12/2014-AVD. IV(B) dated 12th April, 2016, No. 407/02/2016-AVD. IV(Lokpal) dated 24th June, 2016 and No. 407/02/2016- AVD. IV(Lokpal) dated 4th July, 2016 as also Secretary(Personnel)'s D.O. letter No. 407/12/2014- AVD. IV(B) vol. III dated 5th July, 2016 OM addressed to all Secretaries, regarding the furnishing of information relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013.

2. In this regard, it is stated that the last date for furnishing of declaration/information/annual return as on 01.08.2014, 31.03.2015 and 31.03.2016 relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 has been extended upto **31st December, 2016**. Formal amendments to the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 have been notified and uploaded on the website of this Department, i.e., <http://persmin.nic.in/DOPT.asp>.

3. Now the timelines for filing these returns are as follows:-

- i. The first return of assets and liabilities as on 1st August, 2014 - on or before the 31st December, 2016.
- ii. The annual return of assets and liabilities as on 31st March, 2015 - on or before the 31st December, 2016.
- iii. The annual return of assets and liabilities as on 31st March, 2016 should be filed on or before 31st December, 2016.

सा.का.नि. 747(अ).—केन्द्रीय सरकार, लोकपाल और लोकायुक्त अधिनियम, 2013 (2014 का 1) की धारा 44 के साथ पठित धारा 59 की उपधारा (2) के खंड (ट) और खंड (ड) के साथ पठित उपधारा (1) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, लोक सेवक (सूचना और आस्तियों तथा दायित्वों की वार्षिक विवरणी देने तथा विवरणियां फाइल करने में आस्तियों की छूट के लिए सीमाएं) नियम, 2014 का और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात्:—

1. (1) इन नियमों का संक्षिप्त नाम लोक सेवक (सूचना और आस्तियों तथा दायित्वों की वार्षिक विवरणी देने तथा विवरणियां फाइल करने में आस्तियों की छूट के लिए सीमाएं) दूसरा संशोधन नियम 2016 है।

(2) ये राजपत्र में उनके प्रकाशन की तारीख को प्रवृत्त होंगे।

2. लोक सेवक (सूचना और आस्तियों तथा दायित्वों की वार्षिक विवरणी देने तथा विवरणियां फाइल करने में आस्तियों की छूट के लिए सीमाएं) नियम, 2014 के नियम 3 के उपनियम (2) में,—

(क) पहले परंतुक में "31 जुलाई, 2016 को या उसके पूर्व" अंकों और शब्दों के स्थान पर, "31 दिसंबर, 2016 को या उसके पूर्व" अंक और शब्द रखे जाएंगे;

(ख) दूसरे परंतुक में "31 जुलाई, 2016 को या उसके पूर्व" अंकों और शब्दों के स्थान पर, "31 दिसंबर, 2016 को या उसके पूर्व" अंक और शब्द रखे जाएंगे;

(ग) दूसरे परंतुक के पश्चात्, निम्नलिखित परंतुक अंतःस्थापित किया जाएगा, अर्थात्:—

"परंतु यह भी कि ऐसे लोक सेवक जिन्होंने उनको लागू नियमों के उपबंधों के अधीन संपत्ति की घोषणाएं, सूचना और वार्षिक विवरणियां फाइल कर दी हैं, 31 दिसंबर, 2016 को या उसके पूर्व, 31 मार्च, 2016 को यथाविद्यमान पुनरीक्षित घोषणाएं, सूचना या, यथास्थिति, वार्षिक विवरणियां सक्षम प्राधिकारी को फाइल करेंगे।"

NOTIFICATION

New Delhi, the 29th July, 2016.

G.S.R.747(E).—In exercise of the powers conferred by sub-section (1) read with clause (k) and clause (m) of sub-section (2) of section 59 read with section 44 of the Lokpal and Lokayuktas Act, 2013 (1 of 2014), the Central Government hereby makes the following rules further to amend the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, namely:—

1. (1) These rules may be called the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Second Amendment Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, in rule 3. in sub-rule (2),-

(a) in the first proviso, for the words and figures "on or before the 31st day of July, 2016", the words and figures "on or before the 31st day of December, 2016" shall be substituted;

(b) in the second proviso, for the words and figures "on or before the 31st day of July, 2016", the words and figures "on or before the 31st day of December, 2016" shall be substituted;

(c) after the second proviso, the following proviso shall be inserted, namely:-

"Provided also that the public servants who have filed declarations, information and annual returns of property under the provisions of the rules applicable to such public servants, shall file the revised declarations, information or as the case may be, annual returns as on the 31st day of March, 2016, to the competent authority on or before the 31st day of December, 2016."
