**Sub: Special Foundation Course of backlog officers commencing from 07.09.2015 to 18.12.2015 at HIPA, Gurgaon, Haryana - Regarding.**

Sir,

In continuation of this Ministry's letter of even number dated 15.04.2015, 23.06.2015 & 06.07.2015 on the subject, it is informed that DoP&T vide OM dated 23.07.2015, 29.07.2015 & 04.08.2015 has informed that a total of 120 IPS officers (113 IPS officers from 2012 & 2013 Batches and 7 officers from 2006 to 2011Batch) (copy enclosed as Annexure-I), have been nominated for the Special Foundation Course who could not attend the Foundation Course during the induction training and Crash Course, commencing from 07.09.2015 to 18.12.2015 alongwith regular Foundation Course at HIPA, Gurgaon.

2. State Governments are, therefore, requested to provide Telephone/Mobile No., E-mail ID & Office address of all the nominated 120 officers (113 IPS officers from 2012 & 2013 Batches and 7 officers from 2006 to 2011Batch) and relieve them without fail, with the direction to report for the aforesaid Special Foundation Course enabling them to reach the Training Institute on or before 07.09.2015 positively under intimation to this Ministry.

3. DoP&T has also requested to this Ministry to call for reasons from the seven officers who did not attend the Crash Course commenced from 13.07.2015 to 25.07.2015 at Dr. MCRHRD Institute, Hyderabad and take suitable action against them for not attending the Course. The State Governments concerned are, therefore, requested to intimate as to why these seven officers have not attended the Crash Course. State Governments are also requested to take appropriate action against them and furnish the Action Taken Report to this Ministry for onward submission to DoP&T.


