

Dear Sir,

The Commission has been mandated under the Constitution of India to advise upon the framing and amendment of Recruitment Rules for various Civil Posts under the Government of India and under the Administration of Union Territories of India. **According to the Guidelines of the Department of Personnel and Training (DoP&T), the Recruitment Rules thus approved by the Commission, are mandated to be notified by the Ministries concerned within a period of ten weeks from the date of the receipt of the Advice Letter from the Commission.**

2. A review was undertaken in the Commission recently, with regard to the Notification of Recruitment Rules proposed by various Ministries/ Departments which have been approved by the Commission. It has been observed that the said Guidelines of the DoP&T, with regard to notifying of the said Recruitment Rules within the stipulated time period have not been adhered to by your Ministry/ Department. This has resulted in the process of recruitment continuing to be undertaken by your Ministry/Department, based upon the old Recruitment Rules, which in effect would result in difficulty in cadre management and accrual of consequent benefits from the revised Recruitment Rules to the prospective incumbents and also to your Ministry/ Department. It may be noted that the delay(s) thus reported are also reflected in the Annual Report of the Commission, which is laid before the Parliament.

3. A detailed list of the proposals upon which Advice Letters have been issued by the Commission and not notified by your Ministry/ Department, is enclosed for your ready reference. The Commission has desired that the action to notify the said Recruitment Rules may be initiated forthwith and completed by your Ministry/Department within a period of one month. Consequent upon the Notification of the Recruitment Rules as per the list enclosed, a copy of the same may also be forwarded to the Commission for its records and due updation of the Commission's Information System. In case the Recruitment Rules thus approved and listed are not notified due to certain reasons, your Ministry/ Department may specify the reasons for the inability to do so.


